RE: Rains County Roads 1150 and 2420 Bridge Replacements

Dear Mr. Morgan,

Archer Construction has reviewed the on-site condition in Rains County at County Roads 1150 and 2420 south and southeast of Emory. We have assembled costs below for the replacement of each individual bridge with clarifications on the scope of work we will be providing. Our TIPS contract vendor number is 230104. Archer Construction's UEI Number is MTPYVSKRBG85.

Proposed Cost Bridge CR 1150 (CR 1150 Includes 7 each W30 x 90 x 50 Ft for greater distance)	\$ 200,139
Proposed Cost Bridge CR 2420 (CR 2420 includes 40'-0 x 20'-0 width clear bridge)	\$ 167,807
Total if Both Accepted	\$ 367,946

Included in this cost is the following:

- Land clearing and earth excavations that are necessary for new bridge construction.
- Backfill, build new back slopes, and any necessary dirt work to complete project.
- County will provide backfill material including rock and earth fill to contractor for use for back slopes.
- Remove existing steel from existing bridge and retain steel for contractor salvage.

General Clarifications & Exclusions

- County is responsible for rebuilding and paving approaches from existing roadway on each side of new bridge.
- County is to obtain any landowner permissions and right of way acquisitions as needed to start and complete project.
- County is responsible for road closures, bridge out barricades and traffic detours and notifications.
- County is responsible for hauling and disposal of any materials, debris, trees, and brush from construction of bridges.
- We have included a payment and performance bond.
- We have included TIPS fee.
- Tax is not included.
- We have not included any costs for any major site grading, drainage, or utility relocation.
- We have not included any materials testing. Costs for materials testing lab would need to be carried by the ISD.
- We assume that there are no hazardous materials on the site and have not included any costs for testing or remediation.

We sincerely appreciate the opportunity to provide this quote to Rains County and look forward to the possibility of working together. We are available to discuss any scope to help you make the right decisions for your project.

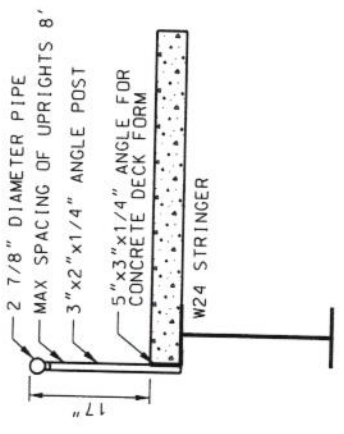
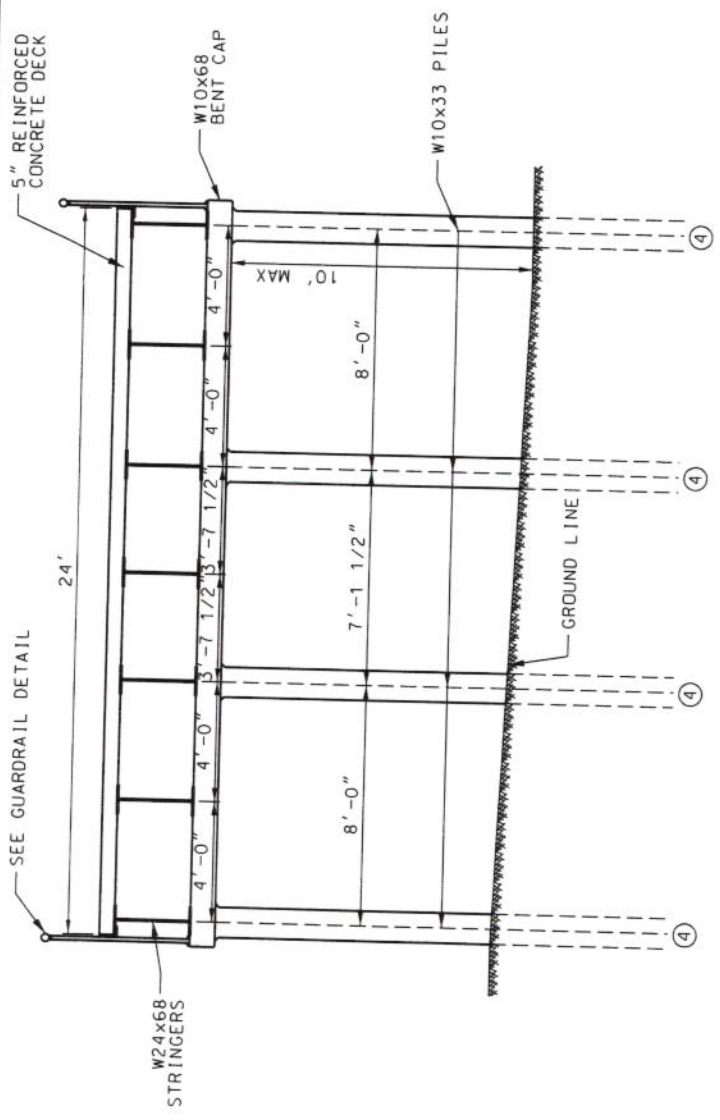

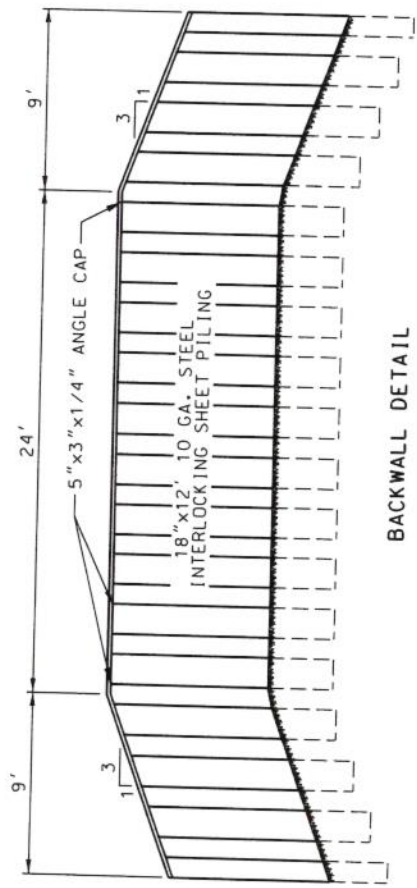
