

**NOTICE BY THE POLK COUNTY COMMISSIONERS COURT
of increases in Elected Officials Salaries, Expenses and Allowances for FY2023**

Pursuant to Local Gov't Code, Sec. 152.013(b)(1)(2), notice is hereby given of proposed increases in elected county/precinct officials' salaries, expenses and allowances for the fiscal year beginning October 1, 2022. These changes represent the annual increase in Longevity Pay (to \$4,000 max.) and any other changes proposed. The Polk County Commissioners Court will set the FY2023 compensation for elected county/precinct officials in a regular session to be held August 15, 2022 at 10:00 a.m. in the Commissioners Courtroom located at 410 E. Church Street, Livingston, Texas.
