

NOTICE OF PUBLIC HEARING ON TAX INCREASE

A tax rate of \$0.6100 per \$100 valuation has been proposed by the governing body of POLK COUNTY.

PROPOSED TAX RATE	\$0.6100 per \$100
NO-NEW-REVENUE TAX RATE	\$0.5728 per \$100
VOTER-APPROVAL TAX RATE	\$0.6136 per \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for POLK COUNTY from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that POLK COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that POLK COUNTY is proposing to increase property taxes for the 2022 tax year.

A public hearing on the proposed tax rate will be held on August 15, 2022 at 10:00 AM at the Polk County Commissioners Courtroom, located at 410 E. Church St, Livingston, TX 77351.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, POLK COUNTY is not required to hold an election at which the voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the COMMISSIONERS COURT of POLK COUNTY at their offices or by attending the public meeting mentioned above.

Your taxes owed under any of the above rates can be calculated as follows:

$$\text{Property tax amount} = \text{tax rate} \times \text{taxable value of your property} / 100$$

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.

The following table compares the taxes imposed on the average residence homestead by POLK COUNTY last year to the taxes proposed to be imposed on the average residence homestead by POLK COUNTY this year.
