Public comments requesting or requiring action or deliberation may be scheduled on a future agenda. Each public comment will be limited to a maximum of three (3) minutes, unless a member of the Court requests additional time for the presenter. Any handout materials must be reproduced prior to the meeting and furnished by the presenter. **After the close of this portion of the Agenda, public comment for the remainder of the Court session is no longer appropriate or accepted unless specifically requested by a Member of the Court.**

3. **PUBLIC HEARING ON PROPOSED 2022 TAX RATE**

A tax rate of \$0.6100 per \$100 valuation has been proposed for adoption by the governing body of Polk County.

Proposed Tax Rate: \$0.6100 per \$100

No-New-Revenue Tax Rate: \$0.5728 per \$100

Voter-Approval Tax Rate: \$0.6136 per \$100

The No-New-Revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for Polk County from the same properties in both the 2021 tax year and the 2022 tax year.

The Voter-Approval tax rate is the highest tax rate that Polk County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the No-New-Revenue rate. This means that Polk County is proposing to increase property taxes for the 2022 tax year.

The proposed tax rate is not greater than the Voter-Approval rate. As a result, Polk County is not required to hold an election at which the voters may accept or reject the proposed tax rate. However, you may express your support or opposition to the proposed tax rate by contacting the members of the Polk County Commissioners Court at their offices, or by attending this public meeting.

**YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE CALCULATED AS FOLLOWS:**

Property tax amounts = (rate) x (taxable value of your property) / 100


